Projects:

An application was being made to Newcastle Building Society's Community Fund for Way Markers in liaison with the Darras Hall branch of the Building Society. 9) Reports from Other Organisations

Friends of Ponteland Park- Heather Thomas said that key projects for 2018-19 were improvement to the shrubbery near Waitrose, replacement of crocuses on the Waitrose Bank and a two year project a daffodil walk.

10) Any Other Business

Issues affecting Ponteland - Mike Brown had emailed the Civic Society concerns on the main issues affected Ponteland at the moment. He had indicated that they was a shortage of public parking spaces with the new bays on Meadowfield needing to be offset by the unofficial spaces lost, the likely overspill from the new flats into the public parking on Thornhill road and no clarity on access to public parking on the rebuilt Schools/Leisure site. A further issue was NCC proposals to apply 'no waiting at any time' restriction to both sides of Middle Drive from the new Darras Hall School to beyond the junction with Crossfell with parent parking likely at Linden Way (access only), Whinfell and Crossfell. The discussion concluded that these comments should be forwarded by the Civic Society to Northumberland County Council.

Grant Application to Ponteland Town Council – A grant application had been made to Ponteland Town Council for funding for the hire of meeting space between October and March 2019 following the decision of Ponteland Town Council to give the PCP 3 months notice. The Clerk had notified the PCP that the application had been rejected as Ponteland Town Council were concerned that funding room hire would leave this open to other groups seeking similar grant funding.

Heather Thomas expressed her concern at the outcome and suggested in the longer term this might impact on the future of the Ponteland Community Partnership. This was because the group was not funded by subscription and organisational running costs were precluded from grant applications for projects.

Frank Harrington also expressed his deep concern in relation to the unique position of the PCP being an Unincorporated Association established under statute and their close working relationship with Councils. The PCP was a group made up of a wide range of supporting community organisations within Ponteland working to identify projects of importance to the community and bidding for community funding. The group had raised significant sums of money (approx £13,000 in 2 years) for project ideas generated from the Neighbourhood Plan for the benefit of Ponteland. These all had contributed towards Britain in Bloom & Ponteland in Bloom.

The PCP greatly appreciated the support that they had received from Ponteland Town Council. The group felt that the latest decision had the potential to impact on their good relationship.
